# 2005 Report from the Representative Council President and Vice-President

*Dear friends,*

**T**HE YEAR 2005 HAS BROUGHT many challenges and changes to Urantia Association International. As we were beginning the year 2005, the Representative Council voted their approval of the By-Laws by a strong majority. Soon after, UAI had its first election to replace some members of the International Service Board (ISB). This first election was a clear manifestation of our newly acquired interdependence with Urantia Foundation. It also heralded our entry into the realm of autonomy, which in turn, brought along the harsh reality of managing a very limited amount of funds provided by individual members and associations.



There was also an RC adopted resolution that provoked a strong reaction on the part of the Urantia Association of the United States Governing Board. This resolution was named Article 6 and prevented messages from the RC to be freely cross-posted to other UAI lists. At this time, this item is still pending at the Judicial Commission, after an appeal was made by the UAUS Governing Board to annul the vote. It should be resolved shortly as the Judicial Commission is now revising the case.

Following the adoption of this controversial article, a new resolution was proposed to provide a more open structure for the RC discussions but it was voted down by the majority of RC members.

As the year progressed there were many RC discussions concerning a request made by the Fellowship to have a joint conference in 2008. This delicate proposal resulted in the RC adopting a set of rules that would, in the future, help UAI process such requests without causing undue turmoil and controversial debate. Following this adopted resolution, a letter was sent to Marvin Gawryn, explaining the position of UAI concerning a joint conference. As long as certain controversial issues are not resolved, there will be no discussions for a joint conference.

Item 33 was passed: “regarding the desirability of changing the name of IUA as part of the re-incorporation of the organization under the laws of the State of Illinois, USA; UAUS moves that the name of the organization be established as International Urantia Association doing business as Urantia Association International. (IUA dba/UAI).”

The RC approved the creation of a new local association in the Dominican Republic. The RC and Urantia Foundation has approved the division of Southern Cone national association, resulting in two local associations, one in Chile and one in Argentina. This will enhance the efficiency and growth of both groups.

There is a resolution on the table at the present time regarding the 2006 Budget and the future status of the central office. We will keep you informed regarding the outcome of the voting.

The Representative Council continues to operate in the Team-Work mode, performing a cutting-edge function – attempting to unite the elected representatives of many cultures in discovering ways and means of bringing light and truth to the Universal Father’s children. ■

Our budgetary requirements are not being met at this time. It is the sincere hope that this situation will be remedied in the near future.

Guy Perron was appointed by the RC as editor of the UAI Journal. ISB approved the initiation of a news magazine, with Cathy Jones, editor.

The UAI Website is being viewed by many people, worldwide. The Webmaster is Mario Caoile, who lends his talents to many areas of communication.

In general, there is an abundance of local and international websites and newsletters.

**B**ecause members gave their support to UAI projects in general, and the Dissemination Committee in particular, cases of books were seeded in Kenya, Lithuania, Zambia, Cameroon and the UK during the past year. And scores of other books were placed in the hands of prison inmates. In its first year, members have used our organization well to spread the light of revelation around the planet at book fairs, in libraries, through translations and in prisons. Teamwork is required to disseminate an epochal revelation to a whole planet. Our organization has shown its ability and potential to accomplish this during 2005.

In 2006, with your continuing help, the Dissemination Committee will double the number of *Urantia Books* seeded around the globe. They will be in several languages and in places as diverse as the nations of *Urantia*. This year's budget includes funds for seeding the book wherever teacher/leaders emerge, especially where material poverty limits access. These leaders and teachers appear more frequently as the previous dissemination endeavors bear their good fruit. Teamwork multiplies the potency of our service. It also hastens the day when the book that so inspired us is within the reach of all our siblings still seeking the light of revelation.

### Study Group Chair

**Rick Lyon**

The Study Group committee produced a “Study Group Starter Kit” that provides suggestions about how to start a study group of *The Urantia Book* and suggestions on how to make a group successful long term. The kit is based on a collection of materials and input from existing study groups. The kit was introduced around the first of October. During the first two months, twenty kits were produced and distributed. The kit was translated into French and Spanish thanks to UAI volunteers from France and Spain. Response to the kit has been very positive. As a result of this, a study group was formed in New Delhi, India, and one in Texas, USA, with other groups in the making.

The committee has solicited photos and articles from existing groups around the world to produce stories for the Tidings newsletter each month. Such sharing of information about existing groups should encourage anyone considering starting a group to do so.

Information about existing study groups has been entered into the UAI database and a letter encouraging all the local organizations to enter information about known study groups in their area was sent to all UAI national and local organizations. It is important to the grassroots function of UAI that the local organizations take the responsibility for entering this information. Local organizations were encouraged to visit study groups in their area to express the UAI's support for all study groups.

We worked with a few people that requested assistance to try to locate study groups near them. As the database information grows, this task will become easier.

The Study Group Committee is seeking someone to help with assembling the Study Group Starter Kits. Each kit includes a list of people interested in study group and any existing study groups in the area of the person ordering the kit. We could use the help of someone willing to research these lists of names in order to produce and ship the kits quicker.

Our plans for 2006 include continuing to produce the starter kit and maintaining contact with those who have received a kit. We plan to submit an article each month to the Tidings newsletter about a study group from somewhere in the world. We will encourage existing

# Study groups in Indonesia

**T**HE URANTIA BOOK STUDY group Prana Cipta Urantia Indonesia wishes to thank those of you that have given aid in the form of copies of *The Urantia Book*. This group recently received 10 books and they will be receiving 6 more. Keluarga Besar Nitiprana says that these books are very meaningful because this study group has 32 members but they only have 2 books to share among them. Their study group time is divided into two meetings: Study Group I (Prana Cipta Spiritual), which started in 1992, and Group II (Prana Cipta Urantia Indonesia), which began in 2002. Keluarga describe the groups in a recent email:


## Study Group I (Prana Cipta Spiritual): 132 people

*The Urantia Book* knowledge takes away from: Bible, Qur'an, Veda, Buddhist, and other religious books.

Our study group consists of 60% Moslem, 30% Christian, and 10% Buddhism and Hindus. We have never had a problem of religion because we study moral and spiritual problems. In our group study, one of the instructions concern-

ing procedure is to open our "spirit eye" to recognize and see "The God Messenger" existing in the human being itself (in *The Urantia Book* referred to as The Adjuster). After they learn to recognize "The God Messenger" (The Adjuster), we introduce *The Urantia Book* to them, and follow up with study of *The Urantia Book* in Study Group II (Prana Cipta Urantia Indonesia).

**In this Study Group II, only about 40% understand English. At the moment we are comprehending knowledge about The Adjuster and human being's journey to the Father in Paradise.**

One of the constraints which we face at this time is that there is no Indonesian translation of *The Urantia Book*. Nugroho Widi of Jakarta is working on this translation for the Urantia Foundation. In this Study Group II, only about 40% understand English. At the moment we are comprehending knowledge about The Adjuster and human being's journey to the Father in Paradise.

# My study group experience

## Madrid Study Group (Spain)

**T**HE SEED THAT WAS SOWN in my mind for the creation of a study group was the visit of Trustee Richard Keeler and Víctor García Bory to Madrid in November 2003. I believe it is important to meet and exchange feelings with the closest people to the Foundation and the International Association, because it shows that there is a real world-wide movement and gives reliability to the movement about the Blue Book.

Several months after this visit, I asked Chicago to give some information about UB readers in my area. Víctor sent a list to me with all the available data from each reader, and put me in touch with the Urantia Association of Spain, for which I asked a list too. With both lists I made a new one with all the available data from each reader.

I had three ways of communication: first, for all whom I had their address, through ordinary mail; second, for all whom I had no address but e-mail, through e-mail; and, last of all, for all whom I had no address nor e-mail, but phone, through a personal call. I followed this order of priority.

I wrote a first letter where I invited to a meeting with date, but without specifying any place (so I didn't know the number of people to come) and where I asked to contact me if they were interested. It's important that the person makes a minimum effort to show their interest. If all is planned with place and time, it's very likely that many people won't attend, because if people don't commit to their attendance they

tend to forget this invitation letter too often.

I made a selection of interested people from the list, about 8 or 9 people, and I set an appointment at my house. In this first meeting the rules of our study group for next meetings were established.

Meetings take place monthly (usually last Sunday of each month) and they last about two hours and a half, with certain flexibility but always being respectful with the host. One member plays the part of facilitator and manages people's turn to speak to avoid crossed or segregated conversations, very typical in our culture. He also does the presentation about the chosen Papers for this day. Then the chosen member proceeds to do the presentation. Meeting after meeting, the part of facilitator is more spontaneous and every one of us can moderate if we feel so inclined. We don't oblige anybody to be the facilitator against their will.

We study sequentially, one document at a time or more than one if they

are related to each other. There is a lot of flexibility in this matter. We will be setting the progress as long as time goes by. I think the role of a "secretary" is also convenient, the one that takes notes about attendance, discussed topics, conclusions, the papers that we're talking about next meeting and the one that is going to do presentations next time.

Before getting started, we observe a minute of silence, that each one uses the way they want to, with the purpose of getting calm and be conscious about the important moment that we're going to live, but with nobody managing this minute of silence. This was a controversial subject, because someone proposed to do a sort of prayer and, before the rejection, I had to play the role of moderator/peacemaker and finally we got this commitment.

With the group experience so far I would like to make some remarks:

- Periodicity of meetings must be assumed for the majority of members. I mean, it's no use that we try ▶

# How The Urantia Book found us

I WAS A CATHOLIC PRIEST FOR 3 years, but 20 years ago I returned to the lay state. I got married and now I have 4 daughters. My greatest problem in the first 2 years was to reconcile my conscience with my faith. I knew I was not wrong in my decision, but sometimes my conscience seemed to disagree.

**But I did not become a reader immediately. The book seemed to be very strange ...**

Then I went to the bookstores seeking for spiritual books and I found J.J. Benitez, an author that uses information from *The Urantia Book* to write his books. Until now, more than 15 years after, we continue without the Portuguese Urantia Book, but it will come soon. After I read the 6th book from Benitez, in 1999, internet was

installed in my job and I did a search for information about those books. How could someone write so elevated theological ideas? I found the answer with a link to the Urantia Foundation web site where I found one PDF Spanish version of *El Libro de Urantia*.

But I did not become a reader immediately. The book seemed to be very strange and I waited more 9-10 months until one more great deception with Catholic Church. That day, on the way home, something like a "voice" in my mind said, "you have that book." Then, in the same day, using a notebook, I became a reader, and afterward I read the entire book at least 3 times. I needed to remake several existential concepts,

but everything ran with softness, and I was happy.

Religion is my largest interest and for my luck is also the main subject of the book. It was very easy to do the first adaptations in my life to turn me into a celestial citizen. The progress has continued and almost every day new steps are revealed.

Today my family, wife as a reader and daughters as listeners, follow *The Urantia Book* teachings, and all of us are very happy with this. □

to make meetings more often if there isn't any real possibility to attend or a serious commitment by all the members. Sometimes we were talking in my group about (and even trying to) make meetings more often, but... what a coincidence! The one who is more insistent is the first not to attend, no matter what the cause was. It's desirable that a meeting takes place once a month and keep a regular attendance.

- Another thing that we have learned is not to bring pressure on the members that don't offer themselves to prepare the work about the paper that is going to be discussed. This must be completely voluntary. It doesn't matter if they are

always the same people presenting the works. Not everybody has got the time or the skills to prepare the work. It's better for a few people working seriously than coming to meetings with nothing prepared and therefore improvising. At the end of each meeting we ask for volunteers to prepare for the next papers (usually two per meeting), even though sometimes we can discuss about only one.

- There is a certain danger in losing time in those study groups where there are couples who, trying to cause a good impression, get the situation complicated about "coffee break", mainly if meetings rotate from house to house. It starts with taking away real time of study, and we must avoid this

giving a stipulated time for break. We usually do it at the end (though this depends on the host), separating study time and social time. On the contrary, a meeting might become a gathering of friends who talk about any matter, not only about the Book. Of course, we talk about the Book in the coffee break, but in a more informal way.

Anyway, we must take into account that, independently of the friendship that may arise among the members, the main objective of the group is to study the Book, to share different points of view and, in short, to enhance and to get better our understanding about the Book.

I hope this experience will be useful for someone. Hugs. □



the branches of the Christmas tree onto the floor and along the wall like a festive river in flood. We have our health. We have each other. We are loved and we love. We are blessed to have so much, I think to myself and close my eyes for a moment.

I look once again at my mom. She is smiling quietly while watching her extended family making all this happy noise in her home. It has not been easy for her. My father died twenty-two years ago at the age of forty-four. He was career Air Force and we traveled extensively, living overseas and many different places here in America. He was also a musician. He always had a band wherever we lived. Usually an eight piece affair, four piece horn section, playing rhythm and blues music. I grew up thinking everyone had an eight-piece

band rehearsing in their living room. He once toured with Lloyd Price. The only white man on stage. He use to come on local TV every Saturday night when we lived in Savannah, Georgia. He played at the American Embassy in England and Morocco, Africa. Their lifestyle was different from almost everyone else we knew. They loved it. But it came to an end with the death of my father. She never remarried.

She also never went to church except for family weddings, funerals and the occasional Easter when we were young and my father was still alive. Due to lifestyle and belief (or lack thereof), both she and my father abandoned the dogma of organized religion long, long ago. She wasn't concerned with Hell. She didn't believe in it.

All my early attempts to talk about *The Urantia Book* never impressed her...as much my fault as anything else. Though over the last few years she would make comments like, "Steve and I kinda believe the same thing." And I would think, how would she know that? She doesn't really know what I believe. She never wanted to talk about God but in the most general of terms. She didn't really want to talk about death at all. We never got to the life after part. These things made her uncomfortable. There was a void between what she didn't believe and what she wished she could. She needed a bridge she could trust. Yet, I recognized the comments she made as a sign that she wanted to believe in something. At long last, she was looking. And I began to see it wasn't my words that impressed her but my actions: she began to question me about the conferences I spoke of participating in, the friends I had made from other states, other countries, my unswerving belief in "this book" over

the years, how these beliefs had changed me from the man I once was. She had seen the change.

Still, it took me by surprise, when earlier this year she said she might like to look at "that book you like to read." Normally, this would be THE SIGN I would look for. But between trying to make sure I did this just right and a hectic lifestyle on my part I actually put it off and then forgot she even mentioned it. Three weeks later she reminded me again: "I thought you were going to bring that book over." Is she serious? Is it more than coincidence she has asked twice? I started making plans on how I would handle her questions. At Thanksgiving, she said, "Hey, where is that book you promised?"

So, there we were: My family gathered around the Christmas tree and everyone is opening presents. Laughter and thank-yous fill the air. There is much movement, noise and merrymaking bordering almost on pandemonium filling up the room. Wrapping paper is flying. My son, Keegan, is the youngest of all the children present. His eyes are shining, full of light and innocence. He is pulling on my sleeve trying to show me his baseball cards. I am watching my mother. She is the only one not moving. Voices began to recede and everything goes to slow motion. She is holding a book. It is opened in her lap and she is reading it. There are colored lights reflecting and moving on the white dust jacket and I am finding it hard to breath. I allow myself one last look before I have to turn away. Everything is blurring. The lights on the Christmas tree are elongating and the stinging sensation is hurting my eyes. Keegan pets my hand and asks if I feel OK. ▶


# Urantia Foundation's Translation and Revision Projects

**I**N EARLY DECEMBER the first truck-load of the newly printed *Das Urantia Buch*, the **German translation**, reached the Head Office of Urantia Foundation. Once the copyright has been secured, the distribution of the German book can begin in earnest. German is spoken as first or second language by some 124 million people; it is the national language of Germany and Austria and one of the four national languages of Switzerland.

*Das Urantia Buch* is the Foundation's eighth printed and tenth available translation. The other available printed translations are: **French** (1963; full revision 1994; 126 million speakers), **Finnish** (1993; 6 million), **Spanish** (1993; 401 million), **Russian** (1997; 280 million), **Dutch** (1997; 21 million), **Korean** (1999; 76 million), and **Lithuanian** (2004; 4 million). Apart for the eight printed books, there are two translations which are still preliminary and available only on CDs:



the **Portuguese** (2003; 186 million) and the **Rumanian** (2004; 30 million speakers). The **Italian** translation will soon be downloadable on the Foundation website.

The next translation to go to the printing press is the **Italian** (62 million speakers). The work is ready to be published, but its distribution has to be organised before the printing machines may start running.

The **Swedish, Estonian, and Polish** stand next in the line. These three translations are at their final stages of improvements and refinements.

Translations on which work is still in progress are: **Farsi (Persian)**, with 47 papers completed; **Japanese** with Part IV and second part Papers 57 through 83 completed; **Chinese**, whose translators have the first draft of Parts II, III,

and IV completed and are currently working on Part I, refining at the same time the first-draft papers; **Greek** with the first draft of the entire book completed and work on perfecting the first draft progressing acceptably; **Czech**, which was launched hardly a year ago and comes with 19 first-draft papers completed. Other translation projects include **Bulgarian** and **Indonesian**, which are progressing slowly.

There are good chances that an **Urdu** translation effort can be launched in near future.

In addition to the above projects the Foundation is sponsoring efforts to revise the existing Spanish translation and to refine the Portuguese and Rumanian translations so to get them into shape fit for print. □
